Policy HC8 is problematic. It requires all major developments to include self-build plots. We have concerns about this policy for the following reasons:

- 1. The policy is a sledgehammer to crack a very small nut. The latest evidence shows a need for 31 entries on the Self Build Housing Register. That level of need can be easily addressed on suitable windfall sites and the suitability of those sites can be assessed against other policies in the Local Plan.
- 2. There is unlikely to be a take-up of self-build plots on large housing estates. Those plots are unlikely to appeal to those on the self-build register whose requirements are larger, individual plots. Other policies on the Local Plan require a minimum of 35dph to be achieved in development sites, this means that the size of any self-build plot will restricted and not desirable for those who wish to build their own home.

The better approach to meet the scale of the identified need for Self-Build homes is to provide support for such applications from windfall opportunities.
