Whilst we have no particular concern with the majority of development being directed to the larger settlements, a significant increase to the overall housing requirement is required, as detailed elsewhere in our representations. Additional development is required across the district's settlements and adjacent to the urban edge of Wolverhampton to meet the increased housing target.
