As detailed within our representations to Table 7, the housing requirement should be revised. The housing requirement in the Plan should be based upon the minimum Standard Method housing figure, upwardly adjusted to take account of affordability factors and economic growth objectives.

The Plan seeks to accommodate just 6% of the unmet housing need arising from the conurbation. This is completely inappropriate, given the functional relationship



between South Staffordshire and the conurbation with limited opportunities for the housing needs of the conurbation to be met elsewhere.

However, as drafted, the housing requirement that is included within the Plan is not robust or based upon an appropriate evidence base. We request the right to attend the examination to express our concern of the significant shortcomings in the Plan in this regard.
