Clowes object to Policy DS2 as written, because it does not align with national policy. Further to representations Clowes submitted to consultation on the preferred options version of the South Staffordshire Plan, we welcome the addition of a policy relating to Green Belt compensatory improvements.

The policy requirement should accord with the wording of the Planning Practice Guidance (PPG) which states that policies for Green Belt compensatory improvements should be "...informed by supporting evidence of landscape, biodiversity or recreational needs and opportunities..." (PPG Reference ID: 64-002-20190722). Compensatory improvements should not necessarily have to improve access, landscape AND biodiversity.
