We **object** to the policy NB4, because it is not in accordance with national policy, justified or effective. This policy proposes to strengthen the protection of trees and hedgerows. The NPPF protects ancient woodland and ancient and veteran trees (paragraph 186c), there is no national requirement to protect all trees.

Trees of course make an important contribution to well-being and provide biodiversity benefits. We do not however consider that Category C or U trees should be afforded any specific protection within the policy. In order for Policy NB4 to be consistent with national policy (paragraph 35d), it should be amended to remove protection of trees which are not defined as 'irreplaceable habitats' (NPPF Annex 2).
