Sport England welcomes the pro forma for the site containing a key requirement of "Provision to be made for replacement playing field land to ensure development results in no net loss of pitch provision". However, it is unclear how this will be achieved with the access route for the development not forming part of the site allocation to establish the impact of the route and the area of replacement playing field land also not identified.

Given the above, it is unclear if replacement playing field land is achievable in line with Policy HC18 and NPPF 103. This therefore raises doubt about the deliverability of the site.
