Clowes objects to policy HC3 as written because it is not justified. Paragraph 8.11 of the SHMA 2022 states that 14.1% of housing should be Affordable Rented / Social Rented.

It is therefore unclear why the policy wording refers to a requirement for 50% social rent, and makes no reference to affordable rent. Further clarification is required on this, in order that the policy can be adequately justified as required by paragraph 35 of the NPPF.

Furthermore we consider that Policy HC3 should be amended to state 'where viable' in order to provide sufficient flexibility and allow tenures to be agreed between SSDC and the applicant on a site by site basis and determined on local need at the time of the application.

Greater clarity is required regarding the justification for the requirement for 50% social rent only in policy HC3, and why it makes no reference to affordable rent.
