Policy NB2 states that "consideration must be given to the aims and objectives of the Local Nature Recovery Strategy".

The Staffordshire and Stoke-on-Trent Local Nature Recovery Strategy ('LNRS') is currently being developed by Staffordshire County Council and Stoke-on-Trent City Council. Therefore, the document has not yet been published and no public consultation has been undertaken on the document. Planning Practice Guidance ('PPG') states that all "planning policies need to be based on up-to-date information about the natural environment" (Paragraph: 043 Reference ID: 61-043-20190315). The PPG also goes on to state that "evidence needs to inform what is in the plan and shape its development rather than being collected retrospectively".

Policy NB2 has not been informed by up to date information and shaped by evidence, as the Local Nature Recovery Strategy has not been produced yet. This policy is therefore not justified or consistent with national policy (NPPF paragraph 35b/d).
