Policy NB4 proposes to amend the adopted Landscape Character policy to strengthen the protection of trees and hedgerows. The policy does not differentiate between different categories of trees.

National Policy only seeks to protect ancient woodland and ancient and veteran trees (National Planning Policy Framework ('NPPF') paragraph 186c), there is therefore no national requirement to protect all trees. The Council has not provided any evidence to justify why 'all' trees should be afforded the same protection. In order to be consistent with national policy (paragraph 35d), Policy NB4 should align NPPF paragraph 186c and only seek to protect ancient and veteran trees unless there are wholly exceptional reasons to justify their removal. Category A and B trees should only be protected 'where possible'.
