Our client objects to draft Policy NB1.

Draft Policy NB1 states in relation to Locally Designated Sites (SBRs and LNRs): "Sites that lie outside of a formal designation but which meet the criteria for designation whether that be statutory or non-statutory site designation will be <u>afforded the same protection as if it were to be designated</u>, and applications affecting such sites must assess the site against the Local Wildlife Site Assessment Criteria.". [Savills emphasis]

The NPPF states that plans should safeguard wildlife-rich habitats "including the hierarchy of international, national and locally designated sites of importance for biodiversity" (paragraph 185a). There is no national requirement to afford all sites which meet the criteria for designation, with the same protection as if it were designated. We therefore consider that the policy should seek to protect only local designated sites.
