In terms of question 71 further clarification is required as to the purpose of compensatory improvements to the environmental quality and accessibility of the Green Belt.

The 5 purposes of the Green Belt as set out in the NPPF are not considered to be related to environmental quality or accessibility. Land allocated as Green Belt within the Local Plan needs to be consistent with the 5 purposes set out in the NPPF and remain precise on these purposes.

In terms of professional interpretation:

"Land is not included in green belts due to its landscape or ecological value." (RTPI)

"Green Belt is a spatial planning tool, not a designation that provides landscape protection. Current Green Belt policy does not require Green Belt to be of high landscape quality or even particularly attractive. Different legislation exists to protect landscapes of value and natural beauty" (Landscape Institute 2018)
